LETTER OF SUPPORT

TO: ROMANIAN PARLIAMENT

REF: Draft Law on the establishment, functioning and organization of counseling cabinets for pregnancy crisis in Romania

"We, the undersigned organizations, commend the initiative of the Romanian Parliament in amending its law on abortion through the *Draft Law on the establishment, functioning and organization of counseling cabinets for pregnancy crisis in Romania* to better protect the health and well-being of mothers while at the same time protecting life. Human life is a fundamental good. As both promulgated and customary international law dictate, the right to life is inalienable and extends to all members of the human family.

The current proposal before the Romanian Parliament on informed consent provides a compelling and reasonable means of bolstering protection to human life while at the same time benefitting the mother. Informed consent laws have been internationally accepted as not placing an undue burden on a woman seeking to procure an abortion. Nor do reflection periods increase health risks to women seeking abortions. To the contrary, studies show that as many as 85 % of women surveyed feel that they they were misinformed or denied relevant information during their pre-abortion counseling.¹

A woman has a right to be fully appraised of all of her possible options before obtaining an abortion, including the alternatives to abortion such as adoption, and should be informed of the risks of complications stemming from abortion including death and the prevalence of post-abortion depression. Society also has a vested interest in the health and welfare of the fetuses in question. Only palpable benefits may stem from the implementation of the proposed informed consent law.

While international abortion groups seek to put pressure on this Parliament to restrict a woman's choice, it is paramount that European law is decisive of the fact that abortion is not a human right

and that individual States have the sole authority to determine the protections they wish to afford to life and to women's health.² Furthermore, there exists no right to abortion under international law, either by way of treaty obligation or under customary international law. No United Nations treaty can accurately be cited as establishing or recognizing a right to abortion.³ Nor does the European Union have competency over the issue of abortion.⁴

The Romanian Parliament therefore has a right and a duty to women and the unborn to enact the proposed legislation. The failure of the current system in Romania is clearly exhibited by a recent case pending with the European Court of Human Rights where the applicant became sterile after obtaining a legal abortion and is now complaining that no competent procedure of informed consent provided her proper warning as to the risks of abortion. We therefore commend the efforts of this esteemed Parliament in seeking to provide much needed protection for the life, health and mental well-being of mothers and for recognizing the immutable good of human life.
